



## 85<sup>th</sup> Anniversary \$850 Giveaway

Main Street, West Bend, WI 53095; 1025 E. Sumner Street, Hartford, WI 53027; or 608 W. Johnson Street, Fond du Lac, WI 54935). Entry form must be submitted at Glacier Hills Location during business hours. Entry must be submitted by October 5, 2019 at 12:00:00 p.m. Entry forms will not be mailed. Entries that are mechanically reproduced, copied, illegible, incomplete, or inaccurate are void. Entries become the property of Glacier Hills and will not be acknowledged or returned. No purchase is necessary to enter or win. A purchase will not increase your chances of winning.
